Further, after 2 years of post-PhD and registration as supervisor in BTU, he/she will be allowed to supervise students as co-supervisor for next 1 year and demonstrate the research guideline capability before he/she entrusted as independent supervisor.		
<b>Agenda Item A6.9:</b>	<b>To approve the minimum time of 1.5 years for thesis submission after the appointment of Co-supervisor.</b>		
Description:	It is observed in some cases that co-supervisors are being added near the thesis submission by the student. So, a guideline of timeline need to framed for it. It is proposed that a PhD research scholar can submit his/her thesis after a minimum of 1.5 years after the appointment of Co-supervisor.		
Resolution:	Approved in addition that the research scholar must have at least one indexed journal paper with the newly appointed co-supervisor.		
<b>Agenda Item A6.10:</b>	<b>To consider and confirm the closer of Research Center of MBA at SGI, Sikar.</b>		
Description:	The purpose of establishing the research centre of MBA at SGI, Sikar is to avail the good academic support to the research scholars who are pursuing their Ph.D. but this purpose has not been fulfilled from the institute end. The University has enquired the actual status of Research Supervisors at the centre of Management of your institute, but there was no satisfactory response received from your side. One of the Research Supervisor, Dr. Karuna Jain has left the institution but this has not been





